Each outdoor market space is 12 feet wide by no more than 40 feet long, as the site allows, to accommodate a vehicle. Vendors must provide their own table(s) and tent(s). Each indoor market space is 10'x10'. Vendors may need to provide their own table(s), as a limited number of picnic tables are available. PREFERENCE: Inside: _____ Outside: _____ FEES: All Speculator Region Chamber Members receive two weeks free or a \$50 reduced rate for the season. **SEASONAL Vendor Rate**: \$200.00 per space for the full season. Payment for seasonal space is due upon submission of the application. Non-payment will result in forfeiture of market privileges. Seasonal pricing guarantees the same space each week and at least one (1) promotional posting on SRCC's Facebook page during the regular season. WEEKLY Vendor Rate: \$35.00 per space per week. To reserve space, you must notify the SRCC no later than Tuesday of that week's market with your intention and preferred location to rent for that week. Weekly payment is due upon your arrival at the market. Weekly vendors are not guaranteed to be assigned the same space. Space is assigned on a 'first come/first serve' basis. Amount enclosed: ___ Refund Policy: Refunds are only issued within 14 days after you apply. No refunds are issued after June 1st, 2025 You must notify the Chamber if you cannot attend the Market when scheduled. All vendors of Agricultural Farm Products must provide two (2) proofs of general liability coverage in the amount of 1 million dollars, one (1) naming the 'Speculator Region Chamber of Commerce' and one (1) naming the 'Village of Speculator' as additional insureds. Certificates must be submitted to the SRCC before the start of the season and will remain on file with the Chamber.
